LAST DATE TO FILE APPLICATION: April 30, 2018

A promotional examination will also be held for this position within City of Tonawanda School District. The Promotional eligible list resulting from this examination may be used first to fill vacancies as they occur.

APPLICATION FEE: There is a \$12.50 non-refundable fee for each examination. The fee must accompany your application. You may pay in cash at the City Treasurer of Office or send a check or money order payable to the City Treasurer. Be sure your name is indicated along with the examination number on your check or money order. This fee will be waived for unemployed heads of households. NO REFUNDS WILL BE MADE if your application is disapproved. Be sure to compare your qualifications carefully with those stated below and file only for examinations for which you qualify.

RESIDENCY REQUIREMENT: There is no residency requirement for this exam.

MINIMUM QUALIFICATIONS: Graduation from high school or possession of a New York State high School Equivalency Diploma and two (2) years of experience in the operation of a steam and/or hot water heating plan, or any equivalent combination of experience and training sufficient to indicate ability to do the work.

SPECIAL REQUIREMENT: Eligibility for an Engineerøs License issued by the City of Tonawanda as follows:

First Class ó High School/Middle School; Second Class ó Fletcher, Mullen & Riverview schools NOTE: A period of eighteen (18) months is allowed from the date of the establishment of the eligible list for the candidate to obtain an Engineer

Elicense in order to be a certified for permanent appointment

GENERAL STATEMENT OF DUTIES: Performs semi-skilled work in the operation and maintenance of steam and/or hot water heating equipment; related work as required.

SUBJECTS OF EXAMINATION: A written test designed to evaluate knowledge, skills and /or abilities in the following areas:

- 1. Operation and maintenance of heating and ventilating systems including steam distribution: These questions test for knowledge of the operating principles and practices involved in steam heating and air handling systems including ventilation equipment, temperature controllers, and typical steam heating and heat distribution methods and equipment.
- **2.** Operation, maintenance and repair of steam-generating systems including related mechanical and electrical equipment: These questions test for knowledge of the operating principles involved in various types of steam boilers and their accessories; the proper operating practices used when working with steam generating systems; and the functions of the various types of auxiliary mechanical and electrical equipment found in steam generating systems.
- **3. Reading of scales and gauges:** These questions test for the ability to read and interpret information displayed on various types of scales, gauges, and meters.
- **4. Mechanical and electrical trades:** These questions test for knowledge of the principles and practices involved in installing, operating, maintaining, and repairing various types of electrical and mechanical equipment used in heating and ventilating systems.

The New York State Department of Civil Service has not prepared a test guide for this examination. However, candidates may find information in the publication "How to take a written test" helpful in preparing for this test. <u>Use of calculators is RECOMMENDED</u>. Devices with spell-checkers, PDAøs, MP3øs, cell phones, texting, paging, camera or other enhanced electronic features are prohibited.

SPECIAL REQUIREMENT FOR APPOINTMENT IN SCHOOL DISTRICTS:

Per Chapter 180 of the Laws of 2000, and by Regulations of the Commissioner of Education, to be employed in a position designated by a school district or BOCES as involving direct contact with students, a clearance for employment from the State Education Department is required.

Your application for this test is part of the examination process. Applications must be completely filled out, with all information stated on the front and back of the form. The Civil Service Commission will not refer to other applications on file for additional information. Applications, which do not show training and/or experience to meet the minimum qualifications, will be disapproved.

APPLYING FOR EXAMINATIONS IN MULTIPLE JURISDICTIONS WHEN EXAMINATIONS ARE SCHEDULED ON SAME DATE: If you have applied for any other Civil Service examinations for employment with New York State or any other local government jurisdiction, you must make arrangements to take all the examinations at one test site. If you have applied for both STATE and LOCAL government examinations, you must make arrangements to take all your examinations at the STATE examination center by cross-filing with the local municipality no later than two weeks before the test date. If you have applied for other local government examinations, call or write to each Civil Service Agency to make arrangements. You must make your request for these arrangements no later than two weeks before the date of the examinations. You must notify all local government Civil Service Agencies with whom you have filed an application of the test site at which you wish to take your examination(s). SPECIAL ARRANGEMENTS: Applicants whose religious beliefs or military service prevent their taking examinations on the scheduled date and disabled candidates who require special accommodations to take the test should indicate the need for special arrangements on their application. Candidates who are called to military service after filing an application should send requests for an alternate test date to the Civil Service Commission as soon as possible before the test date. If special arrangements for testing are required, indicate this on your applications under Question No. 5.

<u>VETERANS</u>: Disabled and non-disabled veterans as defined in Section 85, New York State Civil Service Law, will have 10 and 5 points, respectively added to their earned scores if successful in passing the examination. You must claim these credits when you file the application, but you have an option to waive them any time prior to appointment. If you have already used these credits for a permanent position in NYS, you may not claim them again, <u>with one exception</u>: if a non-disabled veteran used veteranøs credits to obtain an appointment or promotion with New York State or a local government **AND** subsequent to such use, he/she was determined by the United States Department of Veteranøs Affairs to be a qualified disabled veteran, then he/she shall be entitled to apply for and use 10 credits on NYS and local open competitive and promotional exams, minus the number of non-disabled credits he/she had previously used.

CHILDREN OF FIREFIGHTERS AND POLICE OFFICERS KILLED IN THE LINE OF DUTY:

shall be entitled to receive an additional ten points in a competitive examination for original appointment in the same municipality in which his or her parent has served. If you are qualified to participate in this examination and are a child of a firefighter or police officer killed in the line of duty in this municipality, please inform this office of this matter when you submit your application for examination. A candidate claiming such credit has a minimum of two months from the application deadline to provide the necessary documentation to verify additional credit eligibility. However, no credit may be added after the eligible list has been established.

This exam will be prepared and rated in accordance with Section 23 (2) of the Civil Service Law. The provisions of the New York State Civil Service Law, rules and regulations dealing with the preparation and rating of examinations will apply to this examination.
