1. The City of Tonawanda has proposed to directly undertake an action under the  
New York State Environmental Quality Review Act (SEQRA), entitled  
Intermodal Hub Construction.
  2. The proposed action includes construction of a restroom/locker facility with  
bicycle shelter and amenities and a public gathering space.
  3. The proposed location of the project is alongside Koenig Alley between Broad  
and Young Streets.
  4. The applicant's engineer, C&S, Inc. prepared and submitted a Short  
Environmental Form (EAF) for review under SEQRA, Article 8, and 6 NYCRR  
Part 617.

5. The City of Tonawanda Common Council will act as Lead Agency for SEQRA review purposes.
6. The Common Council conducted a review under SEQRA
7. The Common Council has considered the criteria for determining significance as set forth in SEQRA regulations; the Environmental Assessment Form; and project information.

Now, therefore, be it resolved pursuant to the SEQRA Regulations, based upon the information, documentation, and testimony and after examining the relevant issues, the City of Tonawanda Common Council determines the proposed action will not result in any significant adverse impacts on the environment, which constitutes a Negative Declaration of Environmental Significance for the Project for purposes of Article 8 of the Environmental Conservation Law.
