Fire Chaplain Sam Ciffa- I asked if I could have the privilege to say a few words about Judge Cassata. I thought I'd say them before he got all these incredible accolades and achievements he so rightly deserves. My relationship with Judge Cassata goes back a lot longer than even forty years. It goes back to I remember in 1959, public school on the west side of Buffalo #1 School, because my cousin was graduating along with Judge Cassata. I remember looking at the program, every award that could possibly be given including the distinguished Jesse Ketchum award went to Judge Joseph Cassata. My relationship with him and his family has been incredible for over sixty years. From the time I was seven years old playing ball with Ricky going to Cooperstown, working as a union painter with your Dad. Judge Cassata's Dad was a carpenter and did ceiling work, one of the best ceiling men when we would put the grout ceilings in and I was the painter. He was the only carpenter that would say, "Sam come up and paint these three rooms I will be in there tomorrow so you won't have to cut the ceiling line." He would allow me to go in there and paint before he put the grid on. He was the only carpenter that did that. The other guys didn't care. That's how his father was and that's how Judge Cassata was. I did some digging and I found out that Judge Cassata was also the President, I didn't see it on your agenda here Judge, but he was president of his eight grade class also. And it was thanks to my cousin that I heard you were elected Joe because he threatened to beat up anybody who didn't vote for him or not talk to him. But besides that, Judge Cassata for you who don't know this he is a very prestigious singer. I did some digging and in his eighth grade performance wearing his cardigan sweater Judge Cassata did sing to this.

Judge Joseph Cassata- Well, it's interesting because my notes for tonight I always put a heading on it. This says farewell! To my City, to my neighbors, good luck, to Ron, and my other colleagues I see here tonight it's like an alumni meeting, Lynette and others and let it be to my family tonight and I'll be eternally grateful to all you for doing that. It's very special forty-three years is a long time. The problem is I don't know where it went. That's the problem. It's like a blur. Another fact is that I served with six mayors, four council presidents, there would have been more but Carl was there for a long time, twenty seven council members. I've been twenty years as a judge, I can just tell you this, and twenty years ago we had a part-time sort of a rural kind of court. In those twenty years we transformed that court from a part-time court to a full service court. Now what that means as a full service court, we have the resources now for our community, we have the resources for the people that come before us. Resources like specialty courts such as drug court, alcohol treatment court, the mental health court, domestic violence court. I can only tell you this, that this is not just a one man show. There is a team behind every type of court in that we have in our system. And I have just been blessed by having a good team behind me too. Like I said before the more resources we can give to our community, the better the community wins out. I have very fond memories of these halls over forty-three years. Again, personal thank yous go out to everybody and not forget anybody I can only summarize by saying thank you to Ron Trabucco, my City Attorney. Michael Rua my acting judge and Deputy City Attorney, Joe Hogenkamp, our Treasurer for many years, one of the best. Another lady sitting up here and going with me is Jan Bodie. Jan Bodie. I can't tell you how I'm going to miss that early coffee in the morning and going into Jan's office to talk about Larry and Rick. The Police Department, I've been through about five police chiefs. The Chief I remembered some of those names today, I started with Jim Oldenburg. Jim Oldenburg what a great man. And the other chiefs, great men, my friend John who passed away. Then we have of course Police Officer Foels. Please stand up Freddie, Policeman Freddie Foels. Please stand up for just one second. The best of the best not just for the Police Department but for the court. He ran the court for nineteen years. Then we had of course Scottie today and Scarpy the son, wonderful. Dave Ray in the Youth Court, does a great job for Youth Court. Our Fire Department has a Chief today and has had four or five chiefs before him. We can be absolutely proud of both of these departments, Fire and Police. The day they come to your house when your son is about three years old and help save his life. You can even be more proud to be a Fire Chief in the City of Tonawanda. All the department heads and I mean all of them. They are all great people. I would be remiss if I did not thank John and Pete my two maintenance guys. For coming in when I'm working late and I'm bothering them with whatever they are doing. We have some good people working there too. I talk about the former people here today with Alice and Jack, you're all part of this. You should all be up here for what you accomplished and how you care for the City. I and a lot of people like you Jack Gallagher and everybody will never forget your names are still there. My Court Clerk Mary Strobel a Tonawanda lady who has been here an awful long time and all my Court Clerks. I want to congratulate Mark Saltarelli. Mark Saltarelli, newly elected City Judge who takes office on January 1st, he was my Acting Judge for six years. He is quite experienced and quite skilled and quite talented. Judge Saltarelli all I can really tell you is that as you know you were with me and our team is together and we changed lives in the City of Tonawanda and that's your challenge for the next ten years. And I will tell you something Judge Saltarelli, I know you will fulfill that challenge because I've known you for the past six years when you were with me on the bench and you were doing it then. So again, ladies and gentlemen, Judge Mark Saltarelli. I would be remiss if I didn't acknowledge the political system because we don't get here without the political system working. And I would like to say to Gayle Syposs, that I've known for a lot of years at Tonawanda High and she's been with the Democratic Party all those years and she has done a tremendous job. Chris Pillozzi is not here tonight but good words go out to Chris. I see my County Legislator here tonight, my pleasure working

with you too Kev. And all I can say is this, it's bittersweet, it's really bittersweet as much as we all work for retirement, when that day comes sometime you're just not ready for it. BE IT ENACTED by the Common Council for the City of Tonawanda, New York - Local Law No. 3 for the year 2015, entitled:

"Enactment of Residential Investment Exemption pursuant to Section 485 (subdivision to be assigned by the State) of the New York Real Property Tax Law", which provides that:

Residential real property constructed on or after the 1st day of January, 2016 in the city of Tonawanda may be exempt from City taxation as provided in this section.

Such real property shall be exempt for a period of one year to the extent of fifty per centum of the increase in assessed value thereof attributable to such construction and for an additional period of nine years and such exemption shall be computed with respect to the "exemption base". The exemption base shall be the increase in assessed value as determined in the initial year of such ten year period following the filing of an original application, except as provided in the following subparagraph.

In any year in which a change in level of assessment of fifteen percent or more is certified for a final assessment roll pursuant to the rules of the State Board, the exemption base shall be multiplied by a fraction, the numerator of which shall be the total assessed value of the parcel on such final assessment roll (after accounting for any physical after quantity changes to the parcel since the immediately preceding assessment roll), and the denominator of which shall be the total assessed value of the parcel on the immediately preceding final assessment roll. The result shall be the new exemption base. The exemption shall thereupon be recomputed to take into account the new exemption base, notwithstanding the fact that the Assessor receives the certification of the change in level of assessment after the completion, verification and filing of the final assessment roll. In the event the Assessor does not have custody of the roll when such certification is received, the Assessor shall certify the recomputed exemption to the local officers having custody and control of the roll, and such local officers are hereby directed and authorized to enter the recomputed exemption certified by the Assessor on the roll. The Assessor shall give written notice of such recomputed exemption to the property owner, who may, if he or she believes that the exemption was recomputed incorrectly, apply for a correction in the manner provided by Title Three of Article Five of the New York Real Property Tax Law for the correction of clerical errors. The following table shall illustrate the computation of the Tax Exemption:

No such exemption shall be granted unless:

1. Such construction was commenced on or after the 1st day of January, 2016; and
2. The cost of such construction exceeds the sum of Seventy Thousand Dollars (\$70,000); and
3. Such construction is completed as may be evidenced by a Certificate of Occupancy or other appropriate documentation as provided by the owner.

For purposes of this section the term construction shall not include ordinary maintenance and repairs.

Such exemption shall be granted only upon application by the owner of such real property on a form prescribed by the State Board. Such application shall be filed with the assessor on or before the appropriate taxable status date and within one year from the date of completion of such construction.

If the assessor is satisfied that the applicant is entitled to an exemption pursuant to this section, he or she approve the application and such real property shall there after be exempt from taxation and special ad valorem levies commencing with the assessment roll prepared after the taxable status date referred to above. The assessed value of any exemption granted pursuant to this section shall be entered by the assessor on the assessment roll with the taxable property, with the amount of the exemption shown in a separate column.

The provisions of this section shall apply to real property used as the primary residence of the owner.

In the event the real property granted an exemption pursuant to the section ceases to be used primarily for eligible purposes, the exemption granted pursuant to this section shall cease.

The City of Tonawanda shall cause information relating to the availability of such exemption, including requirements and application procedures, to be attached to all building permit applications and copies of such information shall be posted in a conspicuous location in any office or offices where such permits and applications for permits are issued and processed.

This Local Law shall be provided to the Honorable Marc C. Panepinto, State Senator and the Honorable Robin Schimminger, State Assemblyman, as sponsors, for their submission of the Local Law to the New York State Legislature for its approval.

This Local Law shall take effect immediately upon filing with the New York State Secretary of State.

Be and it is hereby introduced before the Common Council of the City of Tonawanda, New York; and

BE IT RESOLVED, that copies of the aforesaid Local Law No. 3 for the year 2015 be laid upon the desk of each member of the Common Council by the City Clerk in accordance with the NYS Municipal Home Rule Law.
