COMMENTS BY THE PUBLIC AFTER RESOLUTIONS

Lynn Casal, 69 Grant Street - Several weeks ago I asked the Mayor and my Councilman if the City of Tonawanda will be lifting the parking ban early so like so many other municipalities have already done. I was told that a resolution would be needed to be put forward in order for this to be changed. Today I noticed a post that was posted in the Tonawanda Community Facebook page with well over 100 comments that were posted. I myself have ample parking but others are not that fortunate. Many years ago I lived above my mother s house on 37 William Street when my daughter was a baby and it had a shared driveway and you didngt have enough room for your cars so I had to walk down to the M&T parking lot which really didnot let me park in there because obviously it was their parking lot and sometimes I was plowed in by snow. It wasnot easy to carry a baby in a car seat and everything else to my house sometimes it was late sometimes it was cold, so I have empathy for others who are having issues with this. The Village of Kenmore local law filing a document that I printed off the site today to maintain a parking ban that the mayor may authorize a change, the start and end dates to address weather or other conditions and is an easy fix and a great gesture to those who struggle with similar issues. I would like to ask the council to support a resolution going forward to change the parking ban to in order to give the mayor more flexibility in making that choice and the power to do so. Thank you for those who took the time to respond to my correspondence today. It was greatly appreciated.

Mike Barry, 48 Erie Street- I am the Vice President of the CTEA. I want to thank you all for this contract. Everything has been going alright and we are here to serve the City. I just want to say thank you.

COMMENTS BY THE COUNCILMEMBERS AFTER RESOLUTIONS

Councilmember Toth- I spoke briefly with Ms. Casal and one of the comments that I did make to her was that as a City we try rely on the Department Heads to guide us with what we think is best sometimes in the City. I know that there were conversations with Mr. Warthling about lifting the parking ban and trying to get that amended. I know that there is a lot of spring time clean-up that he likes to get done at this time. In addition to that, the Mayor can probably attest to this that we most notably know that we are not safe in this area from winter weather until about after St. Patrickøs Day. Although I donøt have any personal opinion as to whether there there or not I do like to rely on our Department Heads and have them guide us. I think Mr. Warthling did a good job in doing that with us this time. Obviously this is something down the road that we can look at for sure and I would certainly be open to those conversations. I thank you for your comments tonight and for coming down and taking the time to speak with us again. Congratulations to all our fine employees on their new contract. As many know, Iøm not a big fan of long term contracts but it is well worth it so congratulations guys. Thank-you.

Councilmember Rautenstrauch- I have nothing to report.

Councilmember Smilinich- I want to thank the DPW. I know we tell Mr. Warthling all the time what a great job that we feel that you people are doing. You are all here so I want to personally thank you all and continue on.

Councilmember Gilbert- Again, congrats back to you guys for getting your seven year contract done. We look forward to a good seven years not having to worry about contract negotiations. I want to reiterate what Mr. Toth said that I did speak to Mr. Warthling about the parking, between the streets clean up, street sweepers. Anytime that we put the parking out at a different time it puts the budget and the time frame of getting things done at a different level. It puts the DPW guys behind the eight ball, but I am open to more discussions if the council is willing. So we will look at that moving forward. I wanted to reach out to the Police Department and congratulate Patrolman Cruz on his off duty work in getting the burglar that was trying to make it look like she was an in house nurse. That was great work on his part and I just wanted to say thank you.

Mayor Davis- We still have checks trickling in for Ethan Ashcroft, so I do not have the total as of yet on the amount of money that been raised by the Police Department, by the Anchor Bar, by everybody. My hats off to everybody in the community for rallying around this young man. Green Beer Sunday was a wonderfully brisk day to get to together to drink beer under a tent. I would like to thank everybody for coming out for that. Harzfest was well attended. I would like to thank them for their continuing work every year to make our community better. I would like to add the CTEA Executive Committee was a pleasure to work with, as was the police, as the fire department was too. I look forward to working with them in the future. Thank you Madam President.

Council President Koch- Shrek the musical will debut March 9th at Tonawanda High School; if you have a chance to check it out please do so. I want to congratulate all the quality students from North Tonawanda, Cardinal OøHara, and Tonawanda High School and thank the organizers who help put together a wonderful evening. As the Mayor said Harzfest was an amazing event. It was so great to see so many friendly community members turn out to help out their foundation. The Harzlak Foundation does so much for our community. So I want to thank them. Lastly, but certainly not least, thank you and shut out to the DPW, for the work that you do, day in and day out, and I was very honored to support that agreement.
