WHEREAS, the title of this Resolution/Ordinance has been published at least once in a newspaper of general circulation, on May 3, 2017, in accordance with Section 2.047 of the City Charter.

NOW, THEREFORE, BE IT RESOLVED, that Chapter 78 Waterways; Article 1. TONAWANDASØGATEWAY HARBOR CORRIDOR BOAT DOCK RULES AND REGULATIONS; Sec. 78-5. Docking time period, which now reads as follows:

It shall be unlawful and a violation of this article for the owner/operator of any boat, vessel or other conveyance to dock, moor or anchor overnight at any public dock located within the Gateway Harbor Park without a paid permit from the harbor master. There is a maximum of five days per stay. Boaters may not return until after seven consecutive days have passed.

Shall be amended to read as follows:

It shall be unlawful and a violation of this article for the owner/operator of any boat, vessel or other conveyance to dock, moor or anchor overnight at any public dock located within the Gateway Harbor Park without a paid permit from the harbor master. There is a maximum of five days per stay. Boaters may not return until after seven consecutive days have past. In the event that the owner/operator of any boat, vessel or other conveyance wishes to extend their stay beyond the allotted five days, the harbor master or his/her designee is hereby authorized to issue additional permits, if and only if space is available.

BE IT FURTHER RESOLVED, that Chapter 78 Waterways; Article 1. TONAWANDAS Ø GATEWAY HARBOR CORRIDOR BOAT DOCK RULES AND REGULATIONS; Sec. 78-6. Special events permit and special events, which now reads as follows:

The mayor is hereby authorized and directed to issue a special events permit to any owner/operator of any boat, vessel or other conveyance for docking use, at no fee, and for a period of time to be determined by the mayor.

The harbor master or his/her designee is hereby authorized and directed to not issue docking permits when an event is being held in the corridor where safety is a factor in the funning of the event.

Shall be amended to read as follows:

The mayor is hereby authorized and directed to issue a special events permit to any owner/operator of any boat, vessel or other conveyance for docking use, at no fee, and for a period of time to be determined by the mayor.

The harbor master or his/her designee is hereby authorized and directed to not issue docking permits when an event is being held in the corridor where safety is a factor in the funning of the event.

Special paid docking permits may be issued during special events within the harbor. The harbor master or his/her designee is hereby authorized to issue a special event docking permit to any owner/operator of any boat, vessel or other conveyance for docking use, for a pre-determined fee and period of time. During Canal Fest, there shall be a special paid permit issued to anyone wishing to dock in the harbor for the duration of that event. This will be a ten day paid permit and will start the Thursday before Canal Fest begins.

BE IT FURTHER RESOLVED, that all other Sections of said Ordinance shall remain unchanged and in full force and effect; and

BE IT FURTHER RESOLVED, that the above amendments shall take effect upon publication of its title in an official newspaper of the City of Tonawanda.

Councilmember Gilbert- Madam President, could you give us a brief synopsis of what this does?

Council President Koch- It increases the fees for the Gateway Harbor Corridor boat docks. It was recommended by Mandy Lofft.

Mayor Davis- Mandy Lofft made the recommendation. The City of North Tonawanda is going to do the same thing. But the fees increase five dollars per day for a boat to dock and ten dollars for an overnight across the board.

WHEREAS, back in 2011 the City Council instituted an Anti-Nepotism Policy which is set froth in Section 4.11 of the Personnel Benefits and Policy Manual for City of Tonawanda Employees; and

WHEREAS, the Common Council has now determined that it is in the Cityøs best interest to amend portions of the Anti-Nepotism Policy, more specifically, Sub. Section 2. entitled Policy and Sub. Section 3. entitled Definitions;

NOW, THEREFORE, BE IT RESOLVED, that Sub Sec. 2 entitled Policy, which now reads as follows:

2. Policy

- 2.1 No City employee may supervise, hire, appoint, remove, or be in a position to discipline another family member of their family closer than their second cousin or their domestic partner. Furthermore, family members are prohibited from working in the same department of work unit if it creates a situation whereby one family member directly reports to, and is supervised by another family member.
- 2.2 No family member may audit the work activity of another family member.
- 2.3 Family members may not be placed in the City's organization structure whereby they both report to the same supervisor.
- 2.4 Administrative staff is prohibited from influencing the employment or employment administration of anyone who is a family member. Employment and employment Administration includes hiring, promotion, transfer, disciplinary action and termination.
- 2.5 Administrative staff is responsible for reviewing employment Administration and decisions within their organizational structure to ensure one family member is not responsible for administrative oversight of another family member.
- 2.6 If an individual serves as a City of Tonawanda elected official no member of that officials immediate family shall serve in the immediate Office of the elected official unless that individual held their position prior to the election or becomes a member of the family following the election.
- 2.7 The city reserves the right to take prompt action if any actual or potential conflict of interest arises involving family members who occupy positions at any level, whether higher or lower, in the same line of authority that might affect the employment decision.
- 2.8 Any individual or employee employed prior to the adoption of this policy statement by the Common Council is exempt.

Shall now read as follows:

2. Policy

- 2.1 No City employee may supervise, hire, appoint, remove, or be in a position to discipline another family member of their immediate family or their domestic partner. Furthermore, immediate family members are prohibited from working in the same Department of work unit if it creates a situation whereby one immediate family member directly reports to, and is supervised by another immediate family member.
- 2.2 No immediate family member may audit the work activity of another immediate family member.
- 2.3 Immediate family members may not be placed in the City's organization structure whereby they both report to the same supervisor.
- 2.4 Administrative staff is prohibited from influencing the employment or employment administration of anyone who is an immediate family member. Employment and employment Administration includes hiring, promotion, transfer, disciplinary action and termination.
- 2.5 Administrative staff is responsible for reviewing employment Administration and decisions within their organizational structure to ensure one immediate family member is not responsible for administrative oversight of another immediate family member.
- 2.6 If an individual serves as a City of Tonawanda elected official no member of that officials immediate family shall serve in the immediate Office of the elected official unless that individual held their position prior to the election or becomes an immediate member of the family following the election.
- 2.7 The city reserves the right to take prompt action if any actual or potential conflict of interest arises involving immediate family members who occupy positions at any level, whether higher or lower, in the same line of authority that might affect the employment decision.
- 2.8 Any individual or employee employed prior to the adoption of this policy statement by the Common Council is exempt.

NOW, THEREFORE, BE IT FURTHER RESOLVED, that Sub Sec. 3 entitled Definition, which now reads as follows:

3. Definitions

- 3.1 Family Member an individual who was related by blood or marriage or whose relationship is that of a relative closer than a second cousin.
- 3.2 Administrative Staff Mayor's office and department heads and directors.
- 3.3 Departmental Work Unit a component of a City department defined and organized by specific work activity and responsibilities and supervised by a departmental supervisor in the direct chain of command responsible to that department head.

Shall now read as follows:

3. Definitions

- 3.1 Family Member an individual who was related by blood or marriage.
- 3.2 Immediate Family Member ó includes parents, spouses, domestic partners, siblings and children.
- 3.2 Administrative Staff Mayor's office and department heads and directors.
- 3.3 Departmental Work Unit a component of a City department defined and organized by specific work activity and responsibilities and supervised by a departmental supervisor in the direct chain of command responsible to that department head.

BE IT FURTHER RESOLVED, that all other Sections of said Personnel Benefits and Policy Manual for City of Tonawanda Employees shall remain unchanged and in full force and effect.
