WHEREAS, Local Law No. 1 for the year 2016 for the City of Tonawanda entitled:

A Local Law authorizing the City of Tonawanda to impose a property tax levy in excess of the limit established in New York State General Municipal Law Article 2, Sec. 3-c

was unanimously introduced by the Common Council on October 4, 2016, and laid upon each Council Member's desk for seven days, excluding Sunday; and

WHEREAS, proposed Local Law No. 1 for the year 2016 has been reviewed and deliberated upon by the Common Council;

NOW, THEREFORE, BE IT RESOLVED, that the Common Council hereby approves and enacts Local Law No. 1 for the year 2016, attached hereto and made a part hereof.

LOCAL LAW NO. 1 FOR THE YEAR 2016

A Local Law authorizing the City of Tonawanda to impose a property tax levy in excess of the limit established in New York State General Municipal Law Article 2, Sec. 3-c

which provides that:

It is the intent of this Local Law to allow the City of Tonawanda to adopt a budget for the fiscal year commencing January 1, 2017, that requires a real property tax levy in excess of the tax levy limit as set forth in General Municipal Law Article 2, Sec. 3-c.

This Local Law is adopted pursuant to subdivision 5 of the General Municipal Law Article 2, Sec. 3-c, which expressly authorizes a local government's governing body to override the property tax cap for the coming fiscal year by the adoption of a Local Law approved by a vote of sixty percent (60%) of said governing body.

The Common Council City of Tonawanda is hereby authorized to adopt a budget for the fiscal year commencing January 1, 2017, that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law Article 2, Sec. 3-c.

If a court determines that any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, individual, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this Local Law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

This Local Law shall take effect immediately upon filing with the Secretary of State.

BE IT FURTHER RESOLVED, that this Public Hearing shall be held on Tuesday, November 1, 2016 at 7:00 P.M. in the City Hall, Common Council chambers, 200 Niagara Street, Tonawanda, New York.

Councilmember Gilbert- Madame President? Can the Mayor just tell us what the proposed tax levy cap is and why it needs to be raised?

Mayor Davis- For next year, the property tax cap is .6%, .6.7 %. and the proposed budget was 2.99.

So, very excited about the turnout and very excited about the prospects and want to thank all the residents for coming out to that meeting and for the Legion for hosting it. Pumpkin Day is this

Saturday at the Millstream Community Gardens from 10:00 A.M. to 2:00 P.M. The weather is probably going to be a little nasty so bundle up if you head out but please stop on by and check it out. TNT game, I'm proud of both teams. The way they played, it was a game until about five minutes left in the fourth quarter but the police did a great job of keeping order and as I said both teams played great. Niagara Street if you have noticed we started construction today on the section from Hinds to Two Mile Creek. We thank everyone for their patience as we improve that street to the Town line. Lastly, a lot of people, been a lot of negativity going around with the Presidential Election and every thing. So I would like to share a bit of good news is that Business First ranked The City of Tonawanda #1 in and all of Western New York for small cities. I will take it a step further, when you factor villages into it of our size we are #3 with the villages of populations of 15,000 or more.
