Sec. 46-41. Selling or Vending

(a) No person shall sell, peddle, hawk or vend upon the streets or public places in the city, by going from house to house soliciting purchases or otherwise, unless a license or permit to do so has been previously obtained by such person from the City Clerk, which license must be shown to any member of the police force on demand.

(b) If the occupant of any residential dwelling or the operator of any commercial venture shall have posted a notice on their said property advising vendors not to solicit upon those premises, any person who shall enter said property, whether or not licensed pursuant to Section 46-41(a) of this Code, shall be in violation of this ordinance.

Sec. 42-51. Concessions

(c) It shall be unlawful for the operator of any concession, whether it be a stand-type or mobile concession, to be in any city-owned park or recreation area, unless the concessionaire has obtained a special permit issued by the office of the Mayor.
